## STAKEHOLDER ENGAGEMENT NOTICE

### DPH-24-012 – Reduction Chamber Standards

Notice is hereby given that the California Department of Public Health (Department) is requesting stakeholder feedback to the questions included below. Your responses will inform the Department on the development of regulations pertaining to the manufacture, sale, and operation of reduction chambers, as authorized by Assembly Bill 351 (Garcia, Chapter 399, Statutes of 2022).

Reduction is a new disposition method for use in the death-care industry, joining burial, cremation, and alkaline hydrolysis. Reduction chambers are containers or vessels that hold human remains during the reduction process. The goal of this questionnaire is to solicit input from and gauge the concerns of communities that may be involved with reduction chamber operations in California. The Department will start accepting applications from Reduction Chamber manufactures and sellers on January 1, 2027, for use in California.

The Department is requesting written comments for the list of questions below. Written comments must be received no later than April 4, 2025.
